THE REQUIREMENT


The States of Guernsey wanted to engage with all of it's 65,000 residents on the Island Development Plan. This plan would be will be the principal policy document the Environment Department uses to determine land planning applications.


Given that the previous development plans were reviewed eleven years ago and prior to adopting Objective Keystone, The States of Guernsey's only solution to this problem was to use a combination of Microsoft Word, Excel and Access to completed the process.

Owing to the controversial nature of land use planning and the general expectation that a large number of representations were likely to be made in support or opposition of the draft Island Development Plan, a system was sought that:

- Enabled intuitive access for stakeholder representation on the Plan
- Increased process transparency resulting in a Plan that takes into account the views of the community
- Storage of all Plan related content in one accessible location for (internal) officers and (external) stakeholders
- Ability to cater for custom extraction of data as required for the inquiry processes
- All of the above to be delivered in a strict project timeframe

THE APPROACH
